

**For a new start in European asylum and migration policy**  
*Civil society and municipalities are committed to a sustainable and unified policy*

**24<sup>th</sup>-26<sup>th</sup> November 2019 in Berlin**

The new European Parliament has been elected, and the new Commission and Council are starting their work. People are seeking protection in Europe but land in crowded refugee camps or are forced to spend weeks wandering on rescue boats that are denied entry into European ports. Some people face violent pushbacks at external and internal borders of Europe, in violation of the rules of the Common European Asylum System (CEAS). A complete agreement on an emergency mechanism for boat refugees has so far not been achieved with the EU Member States that want to go ahead. The reform proposals for the CEAS submitted by the Commission in 2016 are also not progressing. In short, the current situation shows the need for a common European asylum and migration policy. It will now be up to the newly elected European institutions to overcome this deadlock and to reflect on European values and foundations.

But does it really need a comprehensive legal reform? Many of the existing European regulations are not applied or deliberately disregarded. A renewed commitment to refugee protection and unconditional respect for human rights, as formulated 20 years ago by the 1999 European Council in Tampere, is needed:

The objective at that time, which must remain the same today, is to create an "open and secure European Union, fully committed to the obligations of the Geneva Refugee Convention and other relevant human rights instruments, and able to respond to humanitarian needs on the basis of solidarity."

However, there is great cause for optimism: where there is no progress at European and multilateral level, people in their communities are currently taking action to promote the responsible and sustainable reception of refugees. They show through concrete measures on the ground that they want to take responsibility for part of the global challenges. They signal openness instead of isolation.

They join forces with existing networks in new alliances: the city networks *Eurocities* (at European level) and *Solidarity Cities* (at international level), the civil society European network *SolidarityCity* and the movement *Seebrücke* in Germany are examples of initiatives that aim to create space for people in need of international protection or who are looking for better perspectives. These movements now actively influence European and global policies.

Together with civil society organizations and municipalities from France, Germany, Poland and Italy, an action plan will be submitted to the European Commission. Some ideas and objectives will also be sketched out for the German Council Presidency in 2020.

After a successful conference at the beginning of the year in Paris and the publication of the "[Paris Declaration](#)", Diakonie Germany, France terre d'asile and the Heinrich Böll Foundation are organizing a new conference in Berlin that will also include Polish and Italian perspectives from civil society organizations and municipalities.

The event will start on Sunday with an opening dinner, followed by a public event on Monday and will end on Tuesday afternoon with an in-house meeting for the NGOs. Simultaneous Translation in English, French, Italian and German will be provided.
