### **Workshop for European Gender Diversity Trainers & Experts**

#### **Gender Diversity Management in South-East Europe**

**from 10th to 14th November in Berlin/Germany**

The workshop aims at the exchange of experiences and for getting to know best practice examples for implementing gender diversity into systems and structures of society and organisations. We hereby take into account and will work on the still open question, whether and to what extend western Gender Mainstreaming and Diversity Management concepts offer sufficient transferability to other cultures.

With regard to the participants' different personal and professional backgrounds as well as to their national and cultural origin, we will engage in *Gender Diversity dialogues*, analysing what particular competences are needed for Gender Diversity Management as an integrated approach of Gender Mainstreaming and Diversity Management. The main focus will be given on the *potentials* (of the participants as well as of given structures and institutional frames in their countries) for changing systems towards more gender diversity equality.

In the long term, the workshop aims for building a European network of gender diversity experts. Hence the German Diversity Professional Association for Gender-Competent Education and Consulting and the Heinrich Böll Foundation are partners of ILE-Berlin in preparing this workshop as well as EFKA in Krakow and the Slovak Family Planing Association in Bratislava.

As a citizen coming from a EU member state (except of Germany), or from Turkey, Iceland, Norway and Liechtenstein, you can apply for an In-Service Training grant, funded by the EU Lifelong Learning Programme (LLPP).

For applying, please follow these steps:

**1. Preregister for the course**

After having received our pre-confirmation for your participation, you can apply for the LLP-Grundtvig grant. You will be asked by your National Agency to add this pre-confirmation to your application!
